# 1. OPENING

## 4. CHAIRMAN'S REPORT

- 4.1 The Chairman reported that 2010-2013 was generally a modest period for Eastern Dredging Association.
- 4.2 China Dredging Association (CHIDA) hosted the 4<sup>th</sup> International Congress for Dredging Technology Development in Chongqing, China in November 2011. EADA was represented by the Secretary General and one of its Board member from Malaysia.
- 4.3 In 2012, EADA India together with AMET University Chennai, India held a 2 day symposium on Oceanography and Shipping which was well attended by locals.
- 4.4 EADA's membership has not shown any significant growth. However individual chapters of CHIDA and EADA (India) has grown substantially with local companies actively taking up membership.
- 4.5 EADA has continued to offer special subscription rates to its members for EADA's official journal, Port & Dredging Construction Magazine. IADC has also offered to provide EADA's members with their official magazine, Terra et Aqua at special rates. In addition EADA has also provided members complimentary registration of 2 places at each Transport Events Conferences which is held regularly with EADA's region. Members are urged to take full advantage of this offers.

# 6. SECRETARY GENERAL'S REPORT

- 6.1 The Secretary General reported that despite the publicity at various forums especially at regional level, EADA is unable to attract new members although membership under national chapters of CHIDA and EADA (India) is growing steadily.
- 6.2 Board members were requested to promote EADA's activities among companies associated with dredging, port construction & engineering activities within their countries with the hope of attracting new membership.
- 6.3 The symposium in Chongqing, China in November 2011 attracted nearly 300 participants. The one day conference was followed by a river and port tour

on the 2nd day to gauge the shipping and port activities as well ongoing dredging and port construction projects within the river enclave of Chongqing.

6.4 The seminar hosted by EADA (India) and AMET University, Chennai in January 2013 was well received with over 200 participants attending the 2 day event.

He tasked the Secretary General and Capt. K. Subramaniam to pursue the matter to fruition.
- 8.4 The meeting unanimously agreed to record its appreciation to CEDA as the host of the XX WODCON in Brussels for the excellent organization and conduct of the event.
